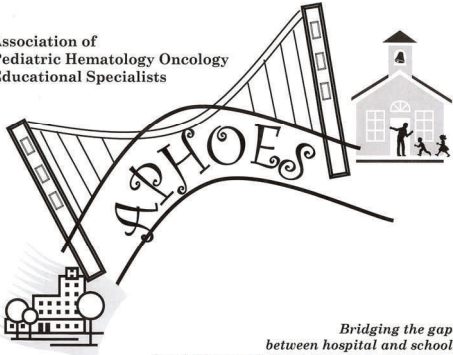

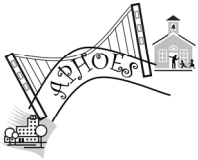

Information on APHOES and Conference Objectives

About APHOES

The Association of Pediatric Hematology Oncology Educational Specialists (APHOES) is a group of professionals (nurses, psychologists, social workers, child life specialists, school and hospital-based educators, physicians and others) that work together to address the educational needs of pediatric hematology and oncology patients. The group first convened in November 2005 out of a shared desire to improve the educational outcomes of pediatric hematology and oncology patients and to standardize the methods that yield positive outcomes. Since that time, APHOES members have gathered several times to draft and refine these standards, to network with other professionals and to collaborate on projects. APHOES began offering professional development opportunities at the working group meetings which has evolved into an annual conference with a robust presentation agenda.

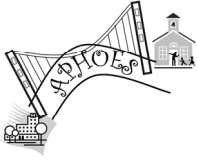
Conference Objectives

Upon completion of the program, attendees should be able to:

- Employ practical strategies to initiate or further develop existing hospital-based school programs to improve the educational outcomes of hematology/oncology patients
- Identify and utilize educational laws and advocacy strategies to support the education of chronically ill students
- Recognize the functional implications and repercussions of specific disease processes and treatments and assist patients and their families with resources and systems of support
- Apply ideas, resources, and strategies to improve the quality of life for patients in active treatment, survivors, family members and school systems in the following categories: Digital-Based Learning, Retention, Survivorship, Educational Interventions, Relationship Building within a School System, and Bereavement Programs for Schools

During and after the program, attendees will have the opportunity to:

- Collaborate, network, and share resources and ideas with professionals from across the country
- Participate in the refinement of standards of practice, assist in the establishment of future directions for APHOES, and engage in a group decision-making process during a formal business meeting and voting for Executive Board positions

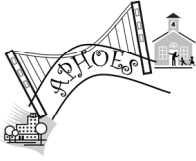
Parking Information

Hilton Parking

Valet parking is available at the Hilton for \$23.00 overnight and \$15.00 for day valet parking. The clearance for hotel valet is 6'6". Self parking is also available at Tower Place Garage adjacent to the Hilton for a charge of \$15 for 12-24 hours. The clearance is 6'8" for this garage.

Transportation Information

The Cincinnati/Northern Kentucky International Airport (CVG) is approximately 13 miles from the Hilton Netherland Plaza Hotel and approximately 17 miles from Cincinnati Children's Hospital Medical Center. Although CVG is the closest and most convenient airport, other airports to consider include: Lexington Airport (LEX), Dayton International Airport (DAY), Louisville International Airport (SDF), and Port Columbus International Airport (CMH).

The Executive Airport Shuttle charges \$20.00 for a one way trip and \$30.00 for a roundtrip between CVG and downtown (the Hilton is located downtown). Taxi service from CVG to downtown Cincinnati is available for approximately \$27.00 (one way).

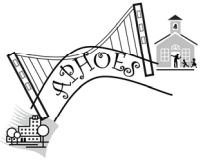

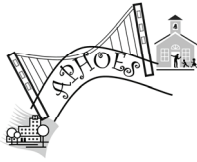
